S102 Approval to extend currency period

On 20 December 2024, the Minister for Economic Development Queensland (MEDQ) decided to approve the application to extend the currency period for PDA development approval DEV2020/1143. The currency period for the approval is now the following:

- MCU preliminary approval 7 years from the date of the decision, being 22 December 2028
- MCU development permit 7 years from the date of the decision, being 22 December 2028
- OPW preliminary approval 7 years from the date of the decision, being 22 December 2028
- OPW development permit 7 years from the date of decision, being 22 December 2028.

It is also recognised that this application benefits from the Covid-19 Applicable Event declaration made by the MEDQ pursuant to s171N of the *Economic Development Act 2012*, which provides a total of an additional 1-year currency period extension. Therefore, the total applicable currency period for this application is 7 years inclusive of the relevant Covid Extensions from the original approval date.
