 - iii) if the applicant is notified under ii.2. above, revised documentation must be submitted **within 20 business days** from the date of notification.

- c) Submit to EDQ DA certification by a Registered Architect confirming that the building has been constructed in accordance with the approved drawings under part a) of this condition.
